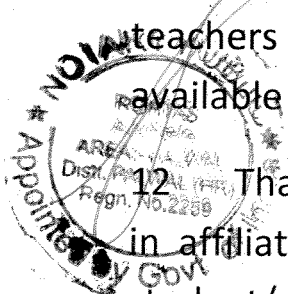
8. That the school will ensure compliance of all statutory requirements EPF,ESI, and labour laws etc. with respect to the school and staff of the school.

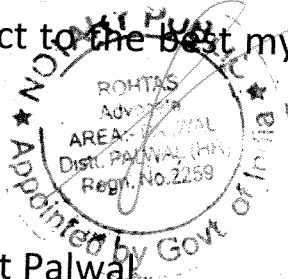
