Whereas the Founders and Trustees of the Trust are desirous of creating a public Educational and Charitable Trust and are therefore desirous of executing the requisite Deed of the Trust setting forth the terms and conditions and provisions thereby for the purpose of permanent and efficient administration of the Trust and have donated Rs.30000/- (Rupees Thirty Thousand only) by cash and through Cheques Rs.2,70,000/- (Rupees Two Lakhs Seventy Thousand only) in all total Rs.3,00,000/- as initial Endowment which is contributed by Founders equally.

Now this Deed witnesseth as follows:-

This Deed of Trust made on 6<sup>th</sup> day of December 2006 by

- 1) SRI ACHALCHAND S/o JAWANMALJI, aged 60 years,
- 2) SRI H.M.OSWAL S/o MANIKCHANDJI, aged 61 years and
- 3) SRI RAJENDRA KUMAR.A. S/o ACHALCHANDJI, aged 38 years,

all are residents of Davangere, hereinafter called as the "FOUNDERS".

- 1. **DECLARATION OF TRUST:-** The Founders hereby declare that aforesaid sum of Rs.3,00,000/- (Rupees Three Lakhs only) initially endowed by them shall exclusively belong to the Trust and form the Corpus and the Founders hereby divests themselves all interest herein and shall in no case revert to the Founders or any of their descendants, relatives, successors, legal heirs or to any other person. The income and funds of the Trust shall be applied towards aims and objects or accumulated for application to the said purposes and such application shall be confined to the aims and objects as set out hereinafter.
- 2. **NAME OF THE TRUST:** The name of the Trust shall be "**SRI SUPARSHWANATH EDUCATIONAL TRUST**".
- 3. **OFFICE:** The Principal Office of the Trust shall be located at Davangere and/or such other place(s) as the Trustees may decide from time to time.
- 4. The benefits of the Trust shall be open to all irrespective of caste, creed, colour, religion or language.



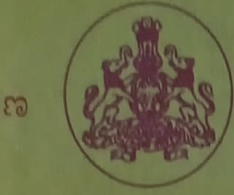

- (i) To ensure that all the objects are for general public and not associated to any religion, caste or creed.
- (j) To acquire, hold and/or construct land and building for the purpose of the Trust.
- (k) To initiate and device suitable measures for collecting the necessary fund.
- (l) To sell, purchase or acquire on lease, mortgage or rent, to mortgage, lease out or exchange of immovable properties of the trust, calculated to secure or conduce to the better management of the affairs of the trust.
- (m) To invest the trust funds, suitably and wisely and to incur legitimate expenses.
- (n) To takeover, help, maintain and administer similar institutions.
- (o) To borrow, raise loans from any person, bank or financial institution in such manner as the trustees deems fit in the interest of the trust.
- (p) To accept Gift, voluntary contributions from any person, firm, institutions or Govt. aid to collect subscription, donation or aid including from the NRI and any person, firm, institutions from the Abroad.
- (q) To do all necessary things for and incidental or conducive for the attainment of above objects of the trust.

8. The Board of Trustees may open and operate Bank Account/s. All the office bearers of the Board may have power to sign cheque. Cheques shall be signed by at least two members.

9. The Board of Trustees have power to appoint working committees of such members as it may deem fit from time to time. At least one trustee shall be appointed in the said committees.

11. **INVESTMENT CLAUSE:** The funds of the Trust shall be invested in the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income Tax Act, 1961 as amended from time to time and such other provisions of such law(s) as may be in force from time to time.
12. **AMENDMENT CLAUSE:** No amendments to the Trust Deed/Memorandum of Association/bye-laws/Rules and Regulations shall be made which may prove to be repugnant to the provisions of Section 2(15) 11, 12 and 13 and 80G of the Income Tax Act, 1961, as in force from time to time. Further no amendment shall be carried out without the approval of the Commissioner of Income Tax or such authority/authorities as may be required as per law in force from time to time.
13. **PROPERTIES AND FUNDS:**
  - (A) **MOVABLE PROPERTY:** Movable property shall consist of :
    - (i) All donations and voluntary contributions to form the Corpus of the Trust.
    - (ii) All gifts, donations and voluntary contributions received in cash or kind that may be made by other charitable or religious institutions or trusts or persons or bodies or sources.
    - (iii) All furniture, materials, stores, equipment etc, which may be acquired or received for use.
    - (iv) Incomes derived by way of interest/dividend/profits on investments of the Trust funds or otherwise howsoever.
    - (v) Income by way of rent from immovable properties and fee and other charges received in respect of the immovable properties of the Trust.

(B) **IMMOVABLE PROPERTY:** The immovable property of the Trust shall consist of all lands, sites, buildings and premises that may be acquired out of the Trust funds for the purpose of carrying out the objects of the Trust by purchase, mortgage, lease, exchange, gift or otherwise whatsoever.

14. The fund of trust shall consist of the amount originally contributed by the Founders of the trust, grant and aids as may be received from the governments and other institutions and bodies, contributions and donations received from the public at large and savings, if any from the education activities and other charitable activities to be carried on by the trust.

18. Everyone of the trustees shall be a life trustee. Each one of the trustee shall subject to clause 36 detailed hereinafter hold office as a trustee during his lifetime and shall be entitles to attend all the meetings of the board of the trustees and participate in them.
19. The board of trustee shall be entitles to function notwithstanding the death, resignations, disclaimer of the office of any trustee, ineligibility (Physical or Mental) of a trustee from functioning and no resolution or decision of the board of trustee shall be invalid on the ground of their being a vacancy at any time.
20. The board of trustee shall meet at least once in a year at the Central Office or at any other place chosen by the Chairperson of the trust. At the meeting of the trustees (the decision of the majority shall prevail). The chairperson shall always have a casting vote, in case of equality of votes. The quorum for such meeting except in case of meetings called as per clause 29 detailed below shall be 75.00% of the total number of the existing trustees, as on the date of notice of meeting. The constitute of a valid meeting the Chair person appointed in terms of clause 16 above shall have be present until and unless he gives his leave of absence in writing.
21. All the office bearers as stated in clause 17 above shall hold office for such period as my be determined by the board of trustees and shall be eligible for reappointment and until the newly elected office bearer enter office and take charge, the old office bearer shall continue.
22. The trustee shall cause true and correct account to be kept of the sums and moneys received and expended on behalf of the trust. Once in every year the account of the trust shall be made and countersigned by the trustees. A chartered accountant appointed by the trustees shall ascertain correctness of the accounts and the balance sheet. The financial year shall be the accounting year.

- 23. Each one of the trustee shall be entitled to nominate, a successor to his office, who shall on the death of trustee, who nominated him. Shall become a trustee, in place of the deceased trustee, as provided hereunder. In case nominee being a male legal heir or spouse of the trustee, such nominee shall automatically become a trustee. In case of nominee being any persons other than the male legal heir or spouse, then the nominee shall become a trustee only if  $\frac{3}{4}$  of the then existing trustees agree to such a nominee becoming a trustee. In the event of nominee, being not accepted as trustee as above, the existing trustees shall have power to co-opt any other person (preferable an heir or blood relation of trustee) as trustee of the trust. On the death of the trustee, without nomination the heirs of such deceased trustee shall within three months from the date of death choose one among the deceased's male legal heirs or his/her spouse as trustee and intimate the same in writing to the board of trustees. In the event of their failures to do so, the board of trustees shall have power, in their absolute discretion to nominate any one of the male heir/spouse of the deceased as trustee. The decision of the board of trustee in this respect shall be final and binding. In case of the nominee/successor being minor, he shall be taken as trustee only on his attaining majority and till then, such vacancy in the board of trustees shall not be filled up.
- 24. The trustees shall have power from time to time to make and alter such rules and regulations with regard to the conduct of the business and all matters in respect of duty hereby vested in them, as they may think proper. The board of trustees, if they so choose, and for the benefit of the trust, may delegate by means of a resolution in writing any or all of the power to any one or more of them or any other person or persons for such time and for such purposes as they deem fit.
- 25. The trustee shall be at liberty to add, to alter or abrogate any of the provisions of the trust apart from the objects of the trust, in a manner not inconsistent with the object of the trust and other stipulations laid herein.
- 26. The trustee shall be wholly indemnified against any expenses and losses incurred or suffered or any payment made by them in the administration of the trust and such expenses, losses and payment shall be borne by the trust and none of the trustees a shall in any way be personally liable or responsible for the same.

27. The trustee shall be respectively chargeable only for such moneys or securities as they shall respectively actually receive notwithstanding their respectively signing and receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipt neglects or defaults and not those of each other not of any banker, auctioneer or other persons with whom or into whose hands any trust moneys or securities may be deposited or come out or for insufficiency in title or difference in value of investments nor for any other loss, unless the same shall happen through their own willful, default respectively.
28. The trustee may reimburse themselves and/or discharge out of the said trust funds, all expenses incurred in or for the execution of the trust and powers of these present.
29. Any four trustee, may in writing, requisition the Chairperson to convene a meeting of the board of trustee clearly disclosing the matter to be discussed by the trustees. Upon such notice the Chairperson shall convey the meeting of the board of the trustee within 45 days after giving fifteen days notice of such meeting to the trustees. In case the Chairperson fails to response to requisition of those trustees, the said trustees, themselves may convene a meeting of trustees giving notice of time of the meeting to all trustees and the decision arrived at such meeting shall be as good, valid and bindings as if the decision arrived at the meeting of the board of trustees duly convened provided that at least 75% of the total number of trustees attend the such meeting and the decision is supported by a 90% majority of the trustees present.
30. The Chairperson shall at all times be competent to call meetings of the board of trustees, saumotto.
31. All or any of the powers vested in or exercisable by the trustees as per this deed of trust shall be capable of being performed or exercised by a majority of trustees present, at the meeting of the board o the trustees and any action/decision of such majority shall, subject to the provision contained in para 29 supra be as valid and effective as it would have been if done by all trustees. If, however in the opinion of the Chairperson the calling of meeting is impracticable for any reason, a resolution passed by the unanimous consent of all the trustee, by circulation of papers shall be as a valid and effective as if passed by the majority of the trustees at a duly convened meeting.

32. The office of trustee will be honorary and the trustees shall not be entitled to draw any remuneration for carrying out their duties.

33. Notice for all meeting of the board either by registered post or courier shall be given to all the trustees and for this purpose the post of communication addressed to the trustee shall be deemed to be a sufficient notice.

34. Any trustee may resign his office by a letter addressed to the Chairperson under his hand. The resignation shall take effect from the time the Chairperson receives, the letter of resignation. If a trustee had made a nomination, before resignation such nominee being male legal heir/spouse or a very close blood relation like brother, shall become a member of the board of trust. If there to be no such nomination, the board of trustee shall appoint any other person (preferably from out of the male legal heirs/spouse) as trustee in place of the person so resigning.

35. A trustee shall cease to be a trustee of the board of trustee:-

- If he acts against the object of the trust or hinders or hampers the progress of the lawful and legitimate activities of the trust.
- If he become insane or subject to such physical or mental disability as to be incapable of taking part in activities of the trust.
- If he convicted by any Court or offence which involves moral turpitude.
- If he does not attend six consecutive meetings of the board of trustee without obtaining the prior permission to present himself from the board of trustee.

However in respect of the clause (a) above the decision of caesura of trustee shall have to be taken by  $\frac{3}{4}$  of the total number of the trustees.

36. When a trustee become subject to any one of the dis-qualifications referred to above and ceases to be a trustee, it shall be competent of the board of trustees to appoint another trustee, from among such trustee's male legal heirs as the board of trustee deem fit or to appoint any other person as trustee.

- (h) To sign and verify all pleading, memoranda or appeal petitions and applications of all kinds, to compromise abandon or refer to arbitration whole or any part of the claim by or against the trust, to engage lawyers/pleaders, advocates and to take all necessary steps.
